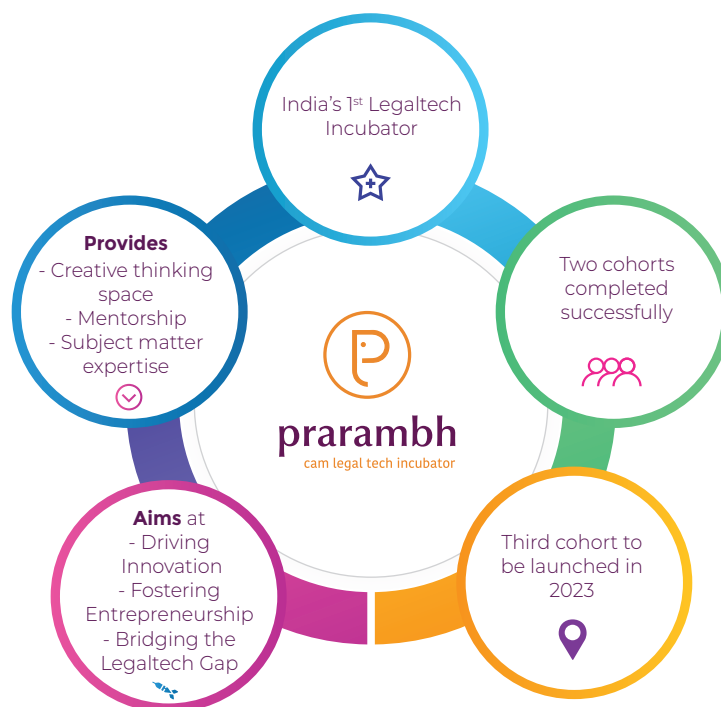

- ▮ Others



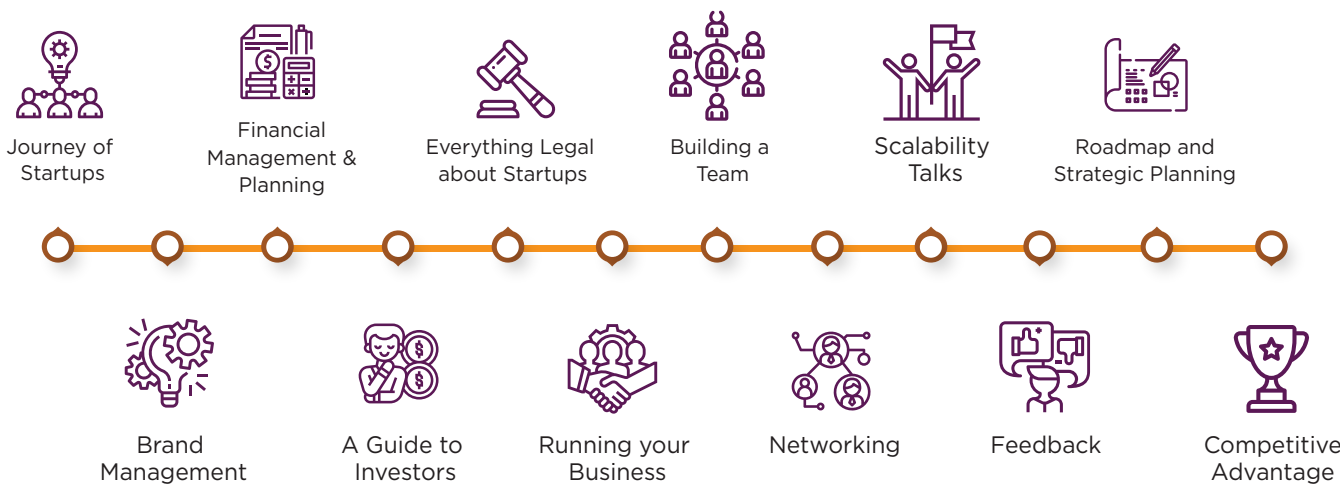

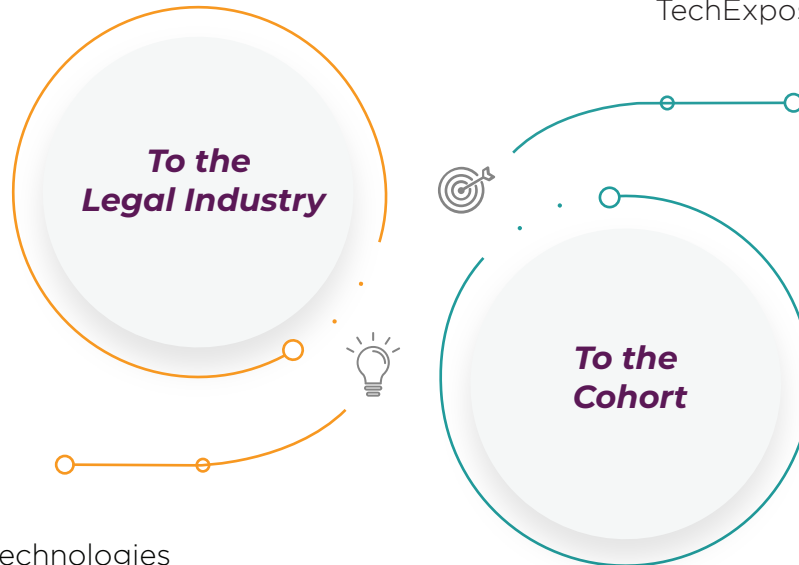
